### Northeast-10 Men's Swimming Athlete of the Week

**Egen Ouellette, Bentley** (So., West Hartford, Conn.) - In a 151-87 win over Saint Michael's, finished first in the 1000 freestyle (10:36.19) and the 100 free (50.22). Also helped Falcons close out the meet with a win in the 400 free relay (3:27.59).
